# International Doctoral Workshop First edition

The Doctoral Program of Law & Social Change and Roma Tre Law Review are pleased to announce that registration is open for the first edition of the International Doctoral Workshop, which will take place on 13-14 October 2023. The event aims to foster the collective discussion and academic exchange of doctoral candidates' projects with their peers and academic staff. It allows participants to gain valuable feedback and promote their work within the extended academic community. Upon evaluation, contributions (aka papers) may be published in an issue of the Roma Tre Law Review.

## Who can attend?

Applications are open to all doctoral students at any stage of their research in the Law Department of Roma Tre University and any other universities of the consortium of the program *Law & Social Change* (Luxembourg, Birkbeck, Vilnius, University College Dublin, Lyon 2, Sydney). Applicants from other universities may be considered depending upon available places and relevance to the research themes of the program.

#### **Themes**

Generally, the event welcomes contributions that seek to understand the current social challenges for Law on the global stage, covering a wide range of domains: financial markets, accounting, corporate governance, transportation, telecommunications, energy, food safety, data gathering and data flow, artificial intelligence, environment, climate change, International and European Regulatory Strategies, consumer rights, security, migrations, Health Law and Post-Pandemic, transnational law, legal theory and comparative legal history, transnational regulatory issues regarding protection of social rights, human rights, digital platforms, data sharing for scientific purposes, digital market, digital consumer protection, corporate prosecution and compliance programs, IP law, online dispute resolution in cross-border litigation, contractual governance.

Contributions can consist of either a presentation of the research project in its most advanced stage or the discussion of a specific topic related to it.

# Registration

Registration and participation in the conference are free of charge. Participants from partner universities should bear the costs of traveling. The University of Roma Tre may be able to assist with accommodation in Rome (further information on this may be obtained from the organizers after confirmation of participation). Candidates must indicate whether they are from abroad or not.

# **Application**

All abstracts should be submitted in English as this will be the conference's official language. Abstracts should be no longer than 300 words and sent to the organizers at <a href="walteralberto.abalonavia@uniroma3.it">walteralberto.abalonavia@uniroma3.it</a>, or noemi.calidori@uniroma3.it before 15 July 2023.

The application should also include: name, family name, mail and keywords. The final draft should be sent to the addresses above before 1 October 2023.

# **Round Tables**

Papers will be presented as part of a thematic round table. Each participant will be paired with a discussant. Presentations should last 15 minutes and will be followed by a general discussion chaired by a relevant researcher or professor. Round Tables will have the following structure:

- A moderator will introduce the panel and present the first speakers (5min)
- The first speakers will present their paper (15 min)
- Comments and replies in the form of an exchange between the two (or more) participants (comments on the substance of the paper will be privileged, the form being reserved for your written comments) (10 min)
- A general discussion with all the participants of the panel will follow (20 min)
- Debrief by the moderator (5min)
