

PRESENTATION

The “argumentative turn” of the 50s and the 60s – which has to be taken as a part of the wider phenomenon of the weakening of Cartesian epistemologies in the 20th century – has provided a flourishing of studies on communicative methods in the various fields of experience for many years. We have seen a true renewal of logic even in its own meaning, thanks especially to some schools of thinking in Europe and Canada.

The rhetorical nature of legal argumentation has been for a number of years the main topic of CERMEG, which has dedicated to it all the previous editions of GTR where lawyers, judges, advocates and experts had the chance of discussing it.

Our aim this year is to create a meeting point for comparison among some of the most remarkable accounts on argumentation and rhetoric, putting them in touch with Italian scholars of legal philosophy. We hope to offer the best conditions for bridging the gap between different theoretical and practical viewpoints.

Working languages: English and Italian.

The Workshop provides an opportunity for scholars and doctoral students to discuss current issues in the field of argumentation and rhetoric.

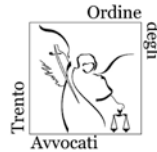
The workshop is free of charge and open to researchers working on argumentation and related issues. Participants pay their own travel and accommodation fees.
